Hopefuls compete for first council seats

El Dorado Hills voters on Nov. 8 will decide whether their community will become an incorporated city.

On the same ballot, they will choose who will represent them as members of the community's first City Council, should the cityhood measure pass.

Today we present information about each of the active candidates vying for the five council seats.

The following are brief rundowns of candidates for an El Dorado Hills City Council to lead that community if voters on Nov. 8 choose to incorporate.



Larry Brilliant

Age: 57.

Occupation: safety and risk management consultant.

Education: MA, public administration, Golden Gate University, San Francisco; BS, criminology,

California State University, Fresno.

Residence: El Dorado Hills.

Family: married, three adult children.

Experience: El Dorado Hills Community Services District board member; El Dorado Hills Fire Department board member, 13 years; charter member, El Dorado Hills Incorporation Committee; member, El Dorado Hills Chamber of Commerce and El Dorado Hills Friends of the Library. "As your new city council member, I will be committed to ensuring the quality of life of El Dorado Hills and to implementing responsible planning that brings limited, quality growth, which is in harmony with the community's quality of life."
